## **REVIEW OF STATE INTEGRATED SCHOOLS**

Paul Ferris and Mark Larson have both been contacted by the Ministry of Education to discuss what might be included in a scheduled review of State Integrated Schools by the incoming government in 2019. The Labour Party Manifesto seems to focus on concerns about access to State Integrated Schools (costs, enrolment processes, etc.) Paul and Mark took the opportunity to raise a number of other matters which included:

- Property costs are the largest single contributor to the cost of attending a State Integrated School –
  any government assistance with defraying property costs is a welcome discussion.
- Teacher training and supply for State Integrated Schools.
- Potential use of a small percentage of Attendance Dues for Special Character development.
- Removal of Maximum Rolls or at the very least the enabling of a more liberal approach to these being increased.

There will hopefully be an update on the Terms of Reference for this review later in the year.

#### **OTHER GOVERNMENT REVIEWS**

The incoming government has announced a wide-ranging set of reviews including:

- An Early Learning Strategic Plan and review of home-based early childhood education
- A review of Tomorrows Schools
- The development of a future focused education work force strategy
- An Action Plan for Learning Support
- Comprehensive reform of school property
- A review of National Standards and NCEA
- Updating Ka Hikitia and the Pasifika Education Plan

APIS and AIS NZ continue to actively monitor these developments and participate as necessary.
